Message from GOAL


Dear Friends of GOAL,

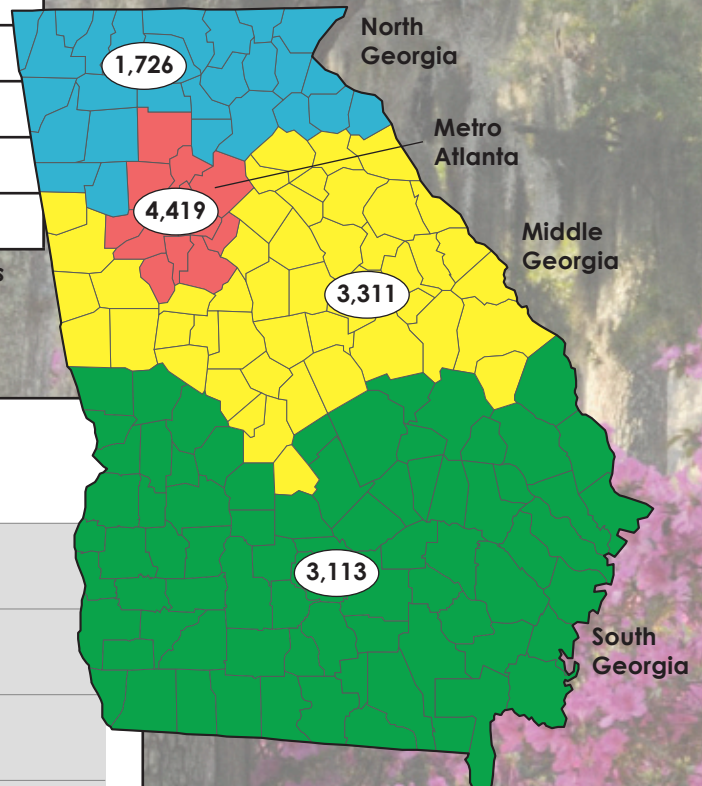

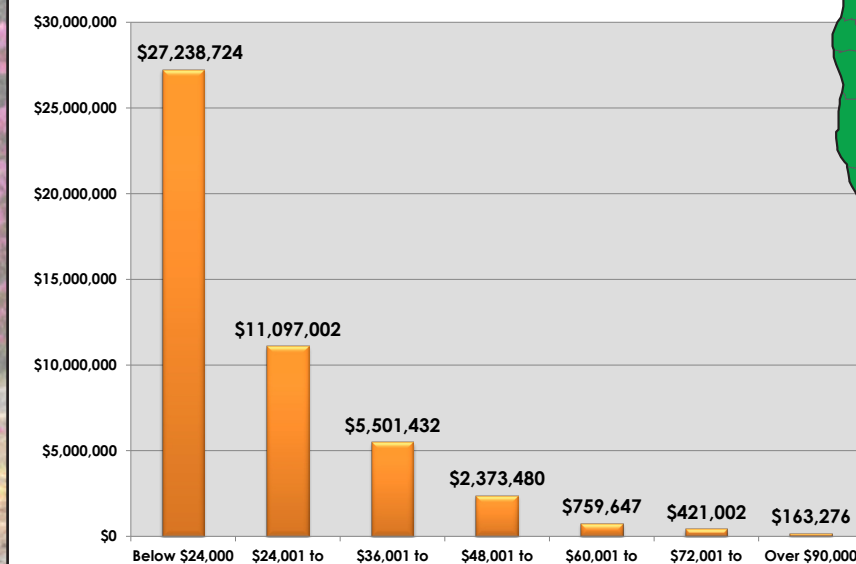

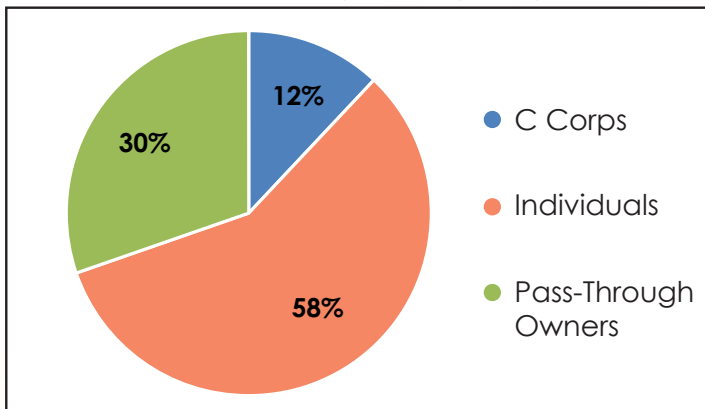

In 2013, GOAL's *Raise the Cap!* petition drive was instrumental to the passage of House Bill 283, receiving signatures from over 3,500 individuals who expressed their support for a cap increase.

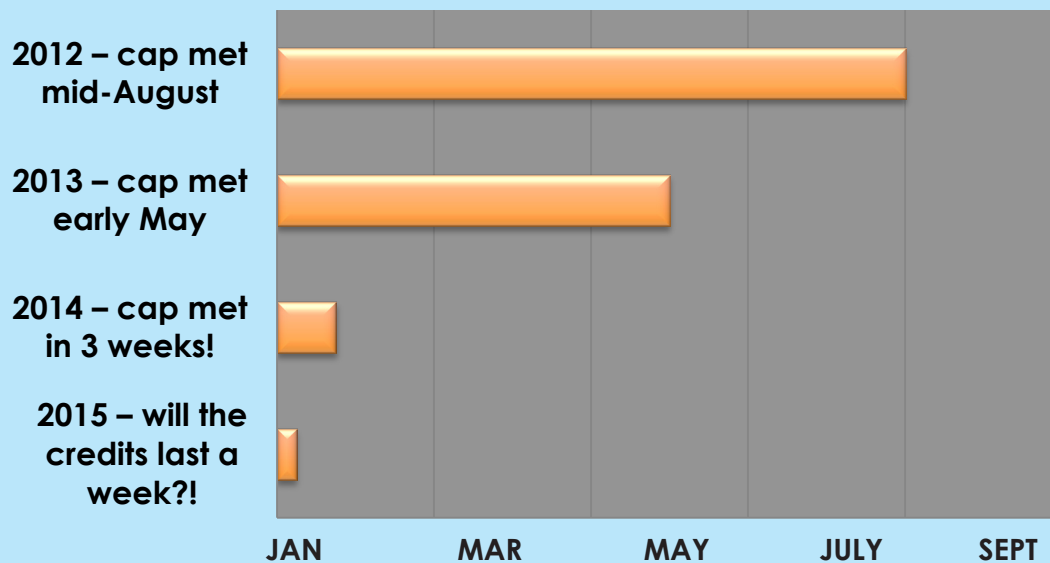
